

#### 8. DUTIES OF OFFICE BEARERS

#### (i) PRESIDENT

The President shall preside over all the meetings of the General body. Governing body and sub-committee. He shall have the right to call for emergency meeting for transaction of the urgent matters if any. He can sanction expenditure to the extent of Rs. \_\_\_\_\_\_ at a time in an year subject to subsequent sanction by the governing body.

#### (III) SECRETARY

The Secretary shall be Chief Executive and shall be in-charge of the management of the office of the Association. He shall be the Correspondent. He shall convince meetings of the General Body. He shall prepare the Agenda for the meetings in consulation with present. He shall maintain the minutes of the proceedings of all meetings. He shall carry out the resolutions passed by the General Body. He has to place before the Governing body every year the revised budget of the academic year and the annual budget of the next academic year. He shall maintain all the registers and accounts of the Association. He shall operate the Bank accounts of the Association jointly with the Treasurer. He can sanction expenditure to the extent of Rs. \_\_\_\_\_\_ at a time in a year subject to the subsequent sanction of the Governing body. He shall look after the day to day administration of the Association.

#### (IV) JOINT SECRETARY

He shall assist the Secretary

#### (V) TREASURER

The Treasurer shall be the Chief custodian of funds of the society. He shall be in-charge of all cash and finance of society. He shall operate the Bank account of the society jointly with the secretary. He shall maintain such accounts as they are prescribed by the Governing body.

#### 11. WINDING UP

In case the society has to be wound up the prosperity and funds of society that shall be transferred or paid or some other institution with similar aims and objects provided the resolution for dissolution receives the assent of at least 3/5ths of the members.
