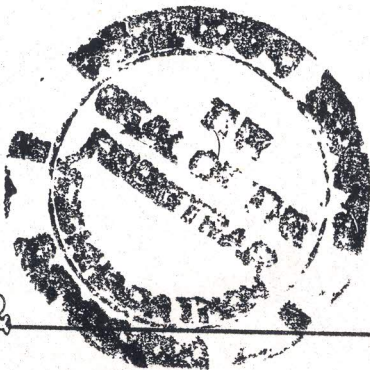

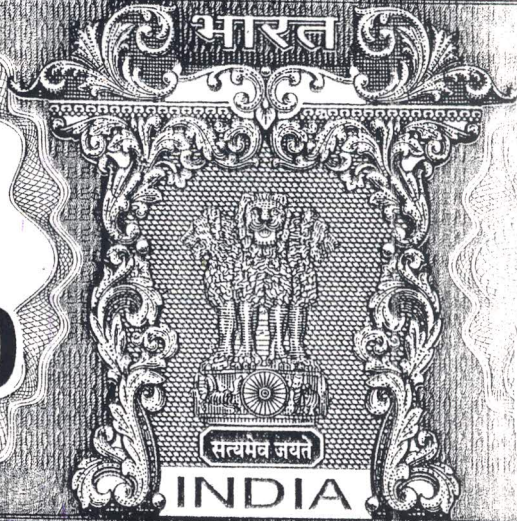

RULES AND REGULATIONS OF THE SOCIETY

1. Name of the Society : ANITS ALUMINI ASSOCIATION

2. Location : D.No. 7A/B,
SANGIVALASA (vill), VISAKHAPATNAM-DIST.
Bheemunipatnam (Mandal)
(Axil Neerukonda Institute of Technology & Sciences)

3. MEMBERSHIP

Ther person who wants to enroll as a member in the Society has to pay Rs. _____ towards membership, and also Rs. _____ towards monthly annual subscription. The person who fails to renew his membership before the end of three succeeding months, automatically ceases to be a member. No member shall be entitled to vote whose subscription shall have been in arrears for a period exceeding three months.

4. GENERAL BODY AND ITS FUNCTIONS

- i) To elect executive body or managing committee.
- ii) To pass budget for ensuing year and approve the expenditure statement of previous year.
- iii) To approve the Report of the activities of the Society.
- iv) To appoint an Auditor

5. EXECUTIVE BODY

The Executive body shall consist of 10 members.

6. MEETINGS

- i) The General body shall meet once in a year in the month of December to elect executive body.
- ii) Extraordinary meetings of the General body may be convened at any time when called for by the Executive body within ten days notice to all members.
- iii) The Executive body will meet once in a month or earlier if there is need for it.

7. QUORUM*

The quorum for both General Body and Executive Body shall be 2/3rd (twothirds) percent and voting.

8. DUTIES OF OFFICE BEARERS**(i) PRESIDENT**

The President shall preside over all the meetings of the General body. Governing body and sub-committee. He shall have the right to call for emergency meeting for transaction of the urgent matters if any. He can sanction expenditure to the extent of Rs. _____ at a time in an year subject to subsequent sanction by the governing body.

(II) VICE PRESIDENT

In the absence of President, he shall perform the the function of the President

(III) SECRETARY

The Secretary shall be Chief Executive and shall be in-charge of the management of the office of the Association. He shall be the Correspondent. He shall convince meetings of the General Body. He shall prepare the Agenda for the meetings in consultation with present. He shall maintain the minutes of the proceedings of all meetings. He shall carry out the resolutions passed by the General Body. He has to place before the Governing body every year the revised budget of the academic year and the annual budget of the next academic year. He shall maintain all the registers and accounts of the Association. He shall operate the Bank accounts of the Association jointly with the Treasurer. He can sanction expenditure to the extent of Rs. _____ at a time in a year subject to the subsequent sanction of the Governing body. He shall look after the day to day administration of the Association.

(IV) JOINT SECRETARY

He shall assist the Secretary

(V) TREASURER

The Treasurer shall be the Chief custodian of funds of the society. He shall be in-charge of all cash and finance of society. He shall operate the Bank account of the society jointly with the secretary. He shall maintain such accounts as they are prescribed by the Governing body.

9. FUNDS

The funds of the society shall be deposited with an approved Bank or in a post office / withdrawal of funds from the bank or post office shall be made jointly and severally by the Treasurer and Secretary. He funds of the Society shall be spent only for the attainments of the objects of the Society and no portion thereof shall be paid or transferred directly or indirectly to any its members through any means.

10. AMENDMENTS

No amendment or alteration unless it is voted by 3/5ths of the members present at a meeting and confirmed by the votes 3/5ths of the members present at a second Special meeting convened by the Governing body at an interval of one month after former meeting.

11. WINDING UP

In case the society has to be wound up the prosperity and funds of society that shall be transferred or paid or some other institution with similar aims and objects provided the resolution for dissolution receives the assent of at least 3/5ths of the members.

On the above, if any changes are to be made in the society Memorandum & Bye laws, under A.P. Societies Registration on Act '2001, Section 8.

12. Disputes Settlement : If any disputes against society Management, the settlement will be made under Arbitration & Con. Cellahon Act, 1996.



13. If the society closes under any reason, the remaining properties of the society are transferred to another Society under AP. Societies Registration 2001, Section 24 & 25
